The Brainiac is a lawyer who, through scholarship and intellectual firepower, has made an impact on the practice of law.

Stuart Wilder was admitted to the Pennsylvania Bar in 1979, the U.S. District Court, Eastern District of Pennsylvania in 1980, the U.S. Court of Appeals for the Third Circuit in 1981, and the U.S. Supreme Court in 1990.
