### Biography

- On behalf of one real estate developer, twice successfully argued in two different counties - Bucks and Montgomery County Courts of Common Pleas that outdated zoning ordinances unconstitutionally excluded convenience stores with fuel dispensing facilities and was granted site specific relief for client. These decisions are yet another example of the courts' ruling that municipalities cannot use outdated and unduly restrictive zoning regulations to prevent this type of use from locating in their municipalities.
- On behalf of a commercial real estate developer, successfully secured zoning ordinance text and map amendment and conditional use approvals to permit the redevelopment of a property to include a convenience store with fuel dispensing facilities, a pharmacy, and three restaurants.
- Assisted client in the purchase of a blighted property in Camden County, New Jersey. Obtained zoning and land use approvals to construct a church on the property.
- Filed an emergency petition for injunctive relief to protect a lessee from a township's efforts to impede and prevent the business from its permitted use of property. Worked with the client to identify an adjacent property for business use. In addition to securing zoning and land use approvals for this site, successfully negotiated and secured a lease for that property.
- Obtained township approval to amend the zoning ordinance to permit a highly-regarded, family owned and operated auto retailer to expand its business operations at a new location.
- Through the use of historical legal precedent, Julie was able to save a national religious institution thousands of dollars in carrying and construction costs and legal fees. In doing so, she enabled the church to erect a new building in a township and block further appeal.
- Obtaining zoning approvals for the addition of a significant expansion to an ice skating rink allowing the rink to double its

size and income.

- Obtaining land development approvals on behalf of a large shipping company client in need of a parking lot expansion that was critical to staying in business at that location; skilled negotiation of the provisions of an agreement also significantly reduced expenses relating to the site development.

Julie offers a well-rounded and thorough approach to her work. Her clients include notable individuals, government bodies and corporate clients in Montgomery, Philadelphia, Chester, Delaware, and Bucks counties, as well as in New Jersey.
